Together with Tony Foglio, the family-owned merchant has purchased co-owner Keith Greggor's shares in the San Francisco based premium craft spirits business. The news follows the recent announcement of the sale of the brewing arm of Anchor Brewers & Distillers to Sapporo Holdings Ltd, Japan's oldest beer brand.

Not only has ADC experienced strong, profitable and consistent growth in revenue of more than 500% over the past few years, but the business boasts a portfolio of over 300 specialty products from more than 20 countries."
